

Greenhouse Gas Emissions Report

Index Analytics (Index) shares the federal government's goal of reducing greenhouse gas (GHG) emissions while maintaining uninterrupted operations in service of our clients.

Index is an ISO 14001 certified company that strongly values the responsible use of natural resources and the preservation of these resources for future generations. Index recognizes the detrimental effects GHG emissions can have on the environment and on our communities. From the removal of disposable plastics in our facility to the study of our GHG emissions, Index is working to reduce our carbon footprint as a company, as well as our individual employees' carbon footprint.

Index calculated the Scope 1 and 2 GHG emissions in accordance with the GHG Protocol Corporate Accounting and Reporting Standard.
